This grant program and publication are funded in full by the California Department of Forestry and Fire Protection (CAL FIRE) as part of the California Climate Investments Program.



California Fire Safe Council (CFSC) is pleased to announce the 2021 CAL FIRE County Coordinators Grant Program awardees! We are also excited to share that CFSC has received a second cycle of County Coordinators funding, allowing us to distribute an additional \$4.2 million to 24 counties located primarily in CAL FIRE's Southern Region in 2022.

The first round of awardees will receive a total of \$4.2 million distributed across 24 counties located in CAL FIRE's Northern Region.

The second round of funding will be released in 2022 and will include 12 pre-selected counties located in CAL FIRE's Southern Region, as well as 12 additional counties. While we will open a new grant application period, the pre-selected counties will be automatically funded and do not need to reapply. See the CAL FIRE Regional Maps located on pg.4 and 5 for more information on regional boundaries.

The objective of the County Coordinators grant project is to educate, encourage, and develop county-wide collaboration and coordination among various wildfire mitigation groups operating within counties containing State Responsibility Area (SRA) lands.

Counties and their Coordinators will working closely with the California Fire Safe Council to: (I) Build a census of all active wildfire mitigation groups in their county, (II) Analyze gaps in county-wide wildfire resiliency and emergency preparedness and develop recommendations to fill these needs, (III) Develop mechanisms to improve outreach and coordination efforts


