California Fire Safe Council (CFSC) is pleased to announce 17 County Coordinator Grant Program awards, located across California. In total, CFSC will award \$2.975 million to these 17 subrecipients.

The objective of the County Coordinator Grant Project is to educate, encourage, and develop county-wide collaboration and coordination among a county's various wildfire mitigation groups.

Counties and their coordinators will work closely with the California Fire Safe Council to: (I) Build a census of all active wildfire mitigation groups in their county, (II) Analyze gaps in county-wide wildfire resiliency and emergency preparedness and develop recommendations to fill these needs, (III) Develop mechanisms to improve outreach and coordination efforts.
